Include self-addressed stamped envelope for return receipt. All dog licenses must be paid for by April 1st, 2026. Second installments should be mailed to Marinette County Treasurer.

Preferred payment method is \*online using our website. Fees are only \$1.50 for e-checks or 2.50% if using debit/credit cards. Other options are mail, in office or Peshtigo National Bank. County Treasurer's hours are 8:00am-4:30pm. Closed 12/24/25, 12/25/25, 12/26/25, 1/1/26 & 1/2/26. Close at noon on 12/31/25. When paying by 1/31/26 make sure payments are sent to proper office listed on first stub to the left.
