Preferred payment method is \*online using our website. Fees are only 25 cents for e-checks or 2.20% if using debit/credit cards. Other options are mail, in office or Peshtigo National Bank. County Treasurer's Hours are 8:00am-4:30pm. Closed 12/24/24, 12/25/24 & 1/1/25. Close at noon on 12/31/24. When paying by 1/31/25 make sure payments are sent to proper office listed on first stub to the left.
